### Fall 2015 Council Meeting, October 9 to 11, 2015, Pittsburgh, PA

On behave of the Vinyl Plastics Division I attended the Fall 2015 Council meeting. The council meetings were:

- Team builder on Friday
- Council on Saturday and Sunday
- CCOW imbedded in the Council meeting on Saturday
  - Division meeting
  - Sections meeting

### Council

The agenda of the meeting is attached. After opening remarks:

- Financial reports
  - The SPE will lose about \$150,000 in 2015. Expenses had to be cut to get it down to that loss. Details are available on Chain. Cash flow is OK, as the line of credit remains open.
  - The budget for 2016 is optimistic. Current projection is to make 3.9 MM and expense is at >3.8 MM.
    - To balance the budget they did reduce rebates to 50% of is due.
  - The checkbook has \$250,000 and our reserve is \$1.3 MM.
  - The Foundation is nearly at \$2.4 MM but is not touchable for operations.
  - New business model Switch from dues base to non-dues revenue. Plan is to do by 2020.
- Membership ٠
  - Currently at 16,600, significantly higher than early this year (14,000).
    - However the increase was due to e-members (free to join).
    - At least 2000 regular members converted to e-members.
    - 3000 e-members new
  - 20,000 members are projected by end of year.
- Communications
  - The Chain was discussed.
  - $\circ~$  ANTEC seems to them to be on the way out. More to Topcons.
  - The use of the SPE website for groups was pushed.






