Called to Order at 6:30PM

First item on the agenda was the election of officers. Some officers have already been selected.

The following officers were nominated and elected. You

General discussion:

Schmidt is suggestion that the MVSPE had to event calendar. This calendar would list MVSPE events as well as other activities of interest to the membership.

Tony Hoog has suggested the Air Force Museum tour or the engineers club as venues that should be considered for a meeting or tour.

The Husky award was discussed. This is a \$5,000 award for a section to sponsor an event or project there is also a student award of \$2500 that is made every year. It was suggested that some effort be made in our presentation for the Husky award and that we encourage student members of the MVSPE to apply for the student award.

Josh Ullrich made a request to have members get advertisers for our newsletter. The newsletter is an electronic and can have a link to advertisers web sites. The cost for a full-page and is \$600 for the nine months at the newsletter is published.

Golf Outing Summary: presented by Dennis Richmond.

Expenses for the golf outing totaled \$8,541.05. The net income from the event was \$1853.95. Some discussion about the allocation of funds to general revenue and the education fund. The hole sponsorship money and raffle ticket profits are to be allocated to the education fund. This education fund goes to scholarships and the sponsoring of students to attend Antech.

Some discussion on chapter revenues was as follows.

We lose money at dinners. We lose money on the newsletter. The goal should be to break even on general revenue basis and build funds for the education fund and make awards.

Rebate money comes back from the national as PE organization as part of member dues are returned to the chapters.

Counselor's report:

Dennis Richmond presented some information about the recent counselors meeting that he attended. See the attached report for details.

Kentuckiana Chapter discussion: this chapter of the SP which is geographically directly south of the MVSPE is in some trouble. If the Kentuckiana Chapter cannot recover from its difficulties the MS in the PE is interested in adopting its members.

Review of minutes from previous meeting: the minutes were reviewed and a motion made for adoption of the minutes by Tom Schmidt. This motion was seconded by Greg Andersen. The board voted unanimously in favor of adopting the minutes.

Upcoming meeting dates:

The schedule for the upcoming meetings is 5:00 p.m. board meeting. 6:00 p.m. networking time. 6:30 p.m. meeting start.

COUNCILOR'S MEETING HIGHLIGHTS

Cincinnati, OH May 5 and 6, 2007

Attendee from MVSPE: Dennis Richmond -Next Council Meeting in Irvine, CA, September 28 and 29, 2007

New Councilors: Attended session for new councilors. There are 100 Sections and 25 Divisions with councilors plus 15 Executive Committee people for approximately 140 voting members on the SPE Council. Key responsibilities of Councilors are to communicate between there sections / divisions and the SPE council and governance.

Recommendation made to have a backup section representative if section councilor is unable to attend the council meetings.

www.4spe.org: An overview presentation was provided on the SPE website. Key points mentioned were:

-Recognition Certificates: Use to recognize members, speakers, officers, etc.

-Speaker List: Contacts for program speakers at monthly meetings

-Financial Information: IRS forms, Financial Report, Treasurer Guidelines

-Credit Card Processing: Allows the sections to turn in credit card payments to National for a 2.7% service charge.

-Membership Chair information and membership details

Side note: Several sections offer a 90 voucher for first meeting for new members.

Key to rebates is to continue to file news letters, annual financial report, IRS form, meeting minutes and Section's goals.

Section Council Committee:

Large portion of the meeting time was directed at sections merging and being abandoned. The Kentuckiana moved from Provisional to Abandonment status. It will still be another year for the Kentuckiana Section to be dissolved.

Briefly Section 9.2 of the By-laws say a section must first be without any activity for at least 2 years, no active board, no leadership and members given notice to join other sections. The process will take another year.

If MVSPE is considering a merger with the Kentuckiana Section, then the in coming MVSPE president is first to make contact with a present member (name unknown) who keeps in contact with National. MVSPE will need to start the process of the merger at the September Council meeting for approval in May, 2008.

Council Committee-of-the-Whole

A motion carried, after lengthy discussion, to try for one year starting in Fall of 2008 the combination of the Fall and Winter meeting. This would require attendance since the ANTEC council meeting counts as two sessions and attendance at 3 is necessary for rebates.

The combining of the meetings will add a Thursday or Sunday to the previous two day venue.

EDUCATION: \$2,500 Husky Student award to six (6) student chapters; (7) applied. \$5,000 Husky Section Award to Australia; (11) sections applied

ANTEC: Next year's ANTEC, in Milwaukee, will include both papers that are theoretical and practical. All papers are to remain educational, but logos and company names can be shown on the papers. Including information on where an

interested party can buy the product. The idea is to offer attendees to make money if they find something useful. This was a result of the member's survey.

There were 656 papers scheduled in 121 sessions. \$428,000 of exhibition space sold, for a total of 17,000 sq. ft, 230 exhibitors. The Cincinnati type city has been a big positive in ANTEC 2007's success. This ANTEC was the first in history to make budget, \$650,000, before the doors opened.

SPE FINANCES: There was a surplus of \$71,000 for 2006. Plus \$90,000 went to the SPE Foundation. Total assets, \$1.35 million.

MEMBER SURVEY: Based on a rating 1 to 5, 5 being highest, the Sections had an

overall rating of 2.9.

-67% SPE dues are company paid

-60% know they are in a section

- -35% attend meetings occasionally
- -3.5 rating for SPE being the source of technical information

-4.1 rating for best source of technical information

-22.7% of members want practical information

-24.9% of members look at SPE for general industry information
